SUBJECT: Store Reset Dates – Fort Meade July 8-26, 2014

The purpose of this “Notice to the Trade” is to provide reset information for the Fort Meade Commissary. The intent of the reset is to support the (HBI) Healthy Base Initiative program. The reset will include areas in Dry Grocery, Chill, Frozen and Produce. The reset schedule will not impact normal store operating hours and will be conducted in the following tiers:

- **Tier 1**, July 8, starting at 9:00 P.M until completed.

- Tier 1, July 9, starting at 9:00 P.M until completed.

- Tier 1, July 10, starting at 9:00 P.M until completed.

- **Tier 2**, July 15, starting at 9:00 P.M until completed.
