SUBJECT: Store Reset Dates – Quantico Marine Corp Base February 2-6, 2015

The purpose of this Notice to the Trade is to provide reset information for the Quantico Commissary. The intent of the reset is to segregate/integrate Natural & Organic items/sections. The reset will include areas in dry grocery, chill, frozen, and produce. Request all Industry and local vendors attend as the schedule is aggressive. The reset schedule will not impact normal store operating hours and will be conducted in the following tiers:

- **Tier 1**, February 2, starting at 8 p.m. until completed.
Baby Food , Can Soup, Gluten Free (General Health), Chill (Silk), Chill Juice (Produce), Frozen Meatless, Frozen Meatless, Frozen Breakfast, Micro Meals, Macaroni & Cheese, Rice Sides, Pasta Sides, Cookies/Crackers, Specialty Crackers, Salty Snacks (Chips), Chill Yogurt, Frozen Bread and Frozen Entrees.
- **Tier 2**, February 3, starting at 8 p.m. until completed.
Condiments (Barbecue Sauce), Condiments (Ketchup/Mustard, Non-Dairy Beverage (Creamers), Frozen Desserts, Hot Cereal, Nuts/Seeds (Misc. Snacks), Pasta Sauce, Cereal, Chill Cheese, Frozen Pizza, Frozen Vegetables and Frozen Fruits.
- **Tier 3**, February 4, starting at 8 p.m. until completed.
Baking (General Health), Peanut Butter, Condiments (Salad Dressings), Energy-Meal Bars (Adult/Diet Nutrition, Condiments Salsa (Mexican Section), Tea, Non Dairy Beverage (Can Milk), Granola (Snack Bars), Juice Shelf Stable (Blends), Carbonated Beverage (Soda), Shelf Stable Fruit and Vegetables, Shortening/Oils and Honey Sweeteners.

Category adjacencies will be worked throughout the reset process February 2-6. In addition to the (Natural/Organic) sets, a partial frozen reset will be conducted.
